Consignor authorizes The Lavish Loft, LLC to sell all or any portion of the items consigned in accordance with the following terms and conditions:

1. Condition of items: We accept items that are in excellent condition, free from defects which include tears, stains, pulls, holes and odors. All items should be freshly laundered, **on hangers** and in **ready to sell condition**. Consigned items later found unsuitable for sale (i.e. stains, holes, missing buttons, etc.) will be donated. (____)
2. Consignment Period is 60 days for all merchandise sold in store. Ebay items are a 90 day consignment, as well as Jewelry. It is your responsibility to contact us when your consignment period is up. End date _____ (____)
3. Pricing: The Lavish Loft, LLC has the final authority on the selling price and reserves the right to reduce the price at our discretion without the consent of the consignor. Prices reflect extensive research using current resale software.
4. Un-Sold Items- All merchandise not sold within the 60 day consignment period and not claimed within 7 days following the end of the consignment period will become the property of The Lavish Loft, LLC and may be donated to our charity of choice, Legacy. **Please call or email before you come pick up.** (____)
5. Consignor Share- Consignor will receive a payment in the amount of 50% of the final selling price when any of their items are sold during the Consignment Term. (70% for items over \$750) Checks will be issued once a month and will include a \$2.00 administration fee. You can pick up your check or request to have it mailed to you (your account will be charged \$.50 to cover the cost of the stamp). The Lavish Loft, LLC does not telephone Consignors regarding their accounts. It is your responsibility to periodically check your account by contacting the main telephone number 856-433-2600 (____).
6. Lost checks- If you would like us to re-issue a lost check, we can do so after 90 days to ensure it wasn't cashed. If you would like us to re-issue it prior to 90 days, there will be a \$33 Stop Payment Fee
6. Risk of Loss- Consignor acknowledges that The Lavish Loft, LLC assumes no liability of loss, destruction or damage of any kind to the consigned items. (____)
7. Indemnification- If any item provided to The Lavish Loft, LLC for resale by the Consignor is found to be counterfeit or if The Lavish Loft, LLC incurs any liability as a result of the sale of such an item, the Consignor agrees to indemnify The Lavish Loft LLC for any damages including any and all judgement, liens, fines, etc. By signing this agreement you warrant that your items are 100% authentic. (____)
